The Company received in-principle approval from Bombay Stock Exchange Limited ('BSE') and the National Stock Exchange of India Limited ('NSE') on June 20, 2024. Additionally, the members of the Company approved this issuance at their meeting held on June 21, 2024. Pursuant to these approvals, the Board of Directors allotted the 543,478 equity shares and 543,477 warrants on a preferential basis on July 2, 2024. The Company is currently in the process of obtaining listing and trading approval for these shares from BSE and NSE.

e. On June 25, 2024, IRIS Regtech Sdn. Bhd, a wholly owned subsidiary of IRIS Business Services Limited was incorporated in Malaysia subsequent to approval from the Board of Directors of the Company, at their meeting held on May 30, 2024. As of the quarter ended June 30, 2024, the subsidiary has not commenced operations and, therefore, has no income, expenses, assets and liabilities. The

incorporation process is complete, and the subsidiary is in the preliminary stages of setting up its operational framework . Figures for the quarter ended March 31, 2024 are the balancing figure between audited figures in respect of respective full financial years and published year to date figures up to the third quarter of the respective financial years which were subjected to limited review.
